

COOKIE POLICY

1. What are cookies?

Cookies are small text files that are downloaded onto the USER's device (computer, smartphone, tablet, etc.) when accessing certain websites. They allow, among other things, the storage and retrieval of information about the USER's browsing habits or their device and, depending on the information they contain and how the device is used, may be used to recognize the USER.

3. Types of cookies used on this website

This PORTAL may use the following categories of cookies:

a) Technical or strictly necessary cookies

These cookies are essential for the proper functioning of the website and allow the USER to browse the PORTAL and use its features, such as:

- Accessing secure areas
- Managing the booking process
- Remembering login details
- Ensuring website security

These cookies do not require the USER's consent.

b) Preference or personalization cookies

These cookies allow the website to remember information so that the USER can access the service with certain characteristics that differentiate their experience, such as language settings or browser type.

c) Analytics or performance cookies

These cookies allow the website owner to track and analyze USER behavior on the PORTAL. The information collected is used to measure website activity and improve its performance and services.

d) Marketing or advertising cookies

These cookies are used to manage advertising spaces in the most efficient way possible by displaying relevant and personalized ads based on the USER's browsing habits.

4. Third-party cookies

This website may use third-party services that, on behalf of BROKAVIA, collect information for statistical purposes, website usage analysis, and the provision of other services related to the PORTAL's activity.

In particular, this website may use:

- Google Analytics or similar web analytics services
- Social media platforms or third-party content services

These third parties are responsible for their own cookie and privacy policies.

5. Legal basis for the use of cookies

In accordance with applicable regulations:

- Strictly necessary cookies are used based on the legitimate interest of the website owner to ensure the proper functioning of the PORTAL.
- All other cookies are only installed if the USER has given explicit consent through the cookie banner or preference panel.

6. How to manage and disable cookies

The USER can allow, block, or delete cookies installed on their device by configuring their browser settings.
